

# **SRI KDU SCHOLARSHIP**

## **(Sri KDU Secondary School – January 2021 Intake)**

### **What is the Sri KDU Scholarship?**

Each year, Sri KDU Sdn Bhd offers a limited number of competitive scholarships for study at Sri KDU Secondary School in levels Secondary 1 to 5. The scholarships are offered to deserving **Malaysian** students with financial need to provide them the opportunity to develop their potential. Our field of applicants is strong and scholarships are highly selective.

Sri KDU Secondary School offers programmes of study leading to the SPM (Sijil Pelajaran Malaysia), as laid out by requirements set by the Ministry of Education, Malaysia. Sri KDU Secondary School aims to bring quality education to students so that they will demonstrate a strong commitment to learning.

Students are accepted to Sri KDU Secondary School in January each year.

### **What does the Scholarship Committee look for in a potential scholarship candidate?**

- Malaysian students aged 12 – 16 years old (as at 1 January 2021) from national and international schools.
- Household income of below RM100,000.00 per annum.
- Strong academic performance.
- Commendable level of oral and written proficiency in English and Bahasa Melayu.
- Other considerations include extra-curricular accomplishments, character, creativity and the ability to contribute to the life of the school.

### **What does the Sri KDU Scholarship cover?**

The scholarship covers the following fees:

1. Registration Fee
2. Annual School Fees

Note:

1. All other fees (including the refundable Deposit\* and examination fee) are to be borne by the student.
2. Scholarships are awarded subject to availability of seats for the level and intake applied.

*\*Refer to the Terms and Conditions listed in this document for the refund of Deposit.*

### **Important dates to note when applying for the Sri KDU Scholarship:**

- 17 July 2020** : The Sri KDU Scholarship (January 2021 Intake) opens for applications.
- 14 August 2020 (by 4:00pm)** : Last day to submit application for the scholarship. Applications that are incomplete or submitted after 4:00pm (Malaysian time) of 14 August 2020 will not be considered.
- End August 2020** : Only candidates who are shortlisted will be notified by the Sri KDU Scholarship Committee via email ([SRIKDU Scholarships@srikdu.edu.my](mailto:SRIKDU Scholarships@srikdu.edu.my)) to continue the next stage of the application process, which includes an interview.  
*Note: Interview attendance together with one parent is compulsory.*
- January 2021** : Scholarship commences for the January 2021 intake.

### How to apply for the Sri KDU Scholarship?

1. Application for the Sri KDU Scholarship (January 2021 Intake) is available only online. Please click [here](#) to apply.
2. Complete the online Sri KDU Scholarship (January 2021 Intake) Application Form and upload the following supporting documents:
  - 2.1 Applicant's current photo (passport-sized).
  - 2.2 Applicant's birth certificate/MyKID/MyKAD.
  - 2.3 Declaration of household income (below RM100,000.00 per annum), together with a certified copy of original EA and full BE Forms. The application will not be considered if this requirement is not fulfilled.
  - 2.4 A typewritten copy of "Special Area of Outstanding Achievement".
  - 2.5 Letter of recommendation from current school principal.
  - 2.6 Latest semester exam results.
  - 2.7 Results/proof of outstanding achievements (games, sport or other relevant areas).
  - 2.8 Proof of involvement in school/community activities.

#### Important Note:

1. Applications must be RECEIVED online by our office by **4:00pm** (Malaysian time) on **Friday, 14 August 2020**.
2. Applications that are incomplete or submitted after the deadline will not be considered.

### Terms and Conditions

1. The scholarship recipient ('recipient') may not concurrently hold any other scholarship without the prior written approval of Sri KDU Sdn. Bhd.
2. The scholarship is tenable until SPM (Secondary 5), subject to annual review and renewal.
3. There will be no bond, except that recipients become active members of the school throughout their studies at Sri KDU Secondary School.
4. The Deposit comprises of the Fee Deposit and Library Deposit ("Deposit"). The Deposit paid is refundable upon full completion of the Secondary 5 programme.  
If the recipient withdraws prior to completion of the Secondary 5 programme, the Deposit is refundable if a written notice of withdrawal is submitted to the Registry Department at least 6 months before the recipient's last day of school.
5. Grades and achievements of the recipient will be reviewed each year by the Sri KDU Scholarship Committee.
6. For End-of-Year review, recipients are required to submit the following documents to the Registrar's Office at the Main Administration Office (Primary School Block) two (2) weeks before the start of Semester 2 year-end school holidays:
  - 6.1 Attendance for the academic year
  - 6.2 Academic and co-curricular performance
  - 6.3 Performance in relevant area/exceptional achievement
  - 6.4 Brief testimonial from the Homeroom Teacher on conduct and behaviour at school, during co-curricular activities, etc.
  - 6.5 A certified copy of each working parent's:
    - 6.5.1 latest filed BE form; and
    - 6.5.2 last 6 months' payslip.
7. Sri KDU Sdn Bhd reserves the right to revoke the scholarship at any time if:
  - 7.1 The recipient's conduct and/or actions bring disrepute to Sri KDU Sdn Bhd and/or any of its schools.
  - 7.2 Clause no. 6 is not complied with.
8. All decisions pertaining to the Scholarship rests with the Chief Executive Officer of Sri KDU Sdn. Bhd. and are final.
